**Notice**

**West Bengal Free ship (WBFS Full free ship/Half free ship) to the poor students in degree level Engineering and Technology courses for the academic session 2022 – 23 (July, 2022- June, 2023)**

In reference to the notification no. **755– Edn (T)/10M –70/2012**, dated 20th December, 2018 of the Higher Education Department (Technical Branch) of Government of West Bengal, applications are invited from the poor students admitted to this college in **degree level engineering & technological courses** for availing full free and half free studentship. 10% of the approved intake shall be eligible for full – free ship and 10% of the approved intake again will be eligible for the half – free ship.

**Eligibility Criteria:**

1. Merit rank in State Level Entrance Examination (WBJEE)/National Level Entrance Examination (JEE-MAINS )
2. Students must be domiciled in the State of West Bengal.
3. Family income of the students must be less than Rs. 2.50 lakhs (Annually) from all sources.
4. Candidates selected under Tuition Fee Waiver (TFW) Scheme of All India Council for Technical Education (AICTE) or West Bengal Swami Vivekananda Merit-cum-Means Scholarship Scheme will not be eligible under this WBFS.

**Determining Criterion:**

Annual Family Income of the students. If clash then JEE Rank

**Quantum of assistance:**

1. In case of students getting full free studentship: Entire tuition fees to be waived for that session.
2. In case of students getting half free studentship: Half of the amount of the existing Tuition fees has to be paid for that session.

**In both the cases the students are to pay university registration fees, examination fees and all other existing fees other than tuition fees.**

Applications along with latest income (from all sources) certificates of the parents and respective testimonials (listed below) in support of their academic performance need to be submitted **via Google**

(i) District Magistrate, (ii) Additional District Magistrate, (iii) Sub Divisional Officer, (iv) Deputy Magistrate, (v) Block Development Officer, (vi) Authorities of Municipal Corporation [i.e. (a) Commissioner, (b) Additional Commissioner, (c) Joint Commissioner, (d) Deputy Commissioner and (e) Assistant Commissioner.

1. Original Income Certificate (Issued by the competent authorities mentioned above).
2. Attested photocopy of Rank Card of WBJEE/JECA/JELET [in case of 1st year students of B. Tech. and 2nd year (JELET) student].
3. Attested photocopies of last two Semester results (in case of 2nd, 3rd and 4th year students).
